THE SHELTER IS STAFFED 24 HOURS A DAY AND DURING THEIR STAY RESIDENTS ARE OFFERED CASE MANAGEMENT SERVICES, 24-HOUR SUPPORT FROM SHELTER ADVOCATES, FOOD, TOILETRIES, AND CLOTHING. THE DAIS SHELTER TYPICALLY ALLOWS FOR A MAXIMUM STAY OF 45 DAYS WHICH HAS PROVEN TO BE VITAL TO A VICTIM'S ABILITY TO DEVELOP LONG-TERM, SUSTAINABLE PLANS AND NETWORKING WITH COMMUNITY SERVICES FOR THEIR FUTURE. OFFERING COMPREHENSIVE CASE MANAGEMENT SERVICES IS ESSENTIAL TO ENSURING THAT WHILE IN SHELTER RESIDENTS RECEIVE THE SUPPORT, INFORMATION, COMMUNITY RESOURCE REFERRALS AND ASSISTANCE IN ACCESSING SERVICES AND RESOURCES THAT ARE NECESSARY TO REBUILD THEIR LIVES. DURING THE PANDEMIC A REDUCED SHELTER CENSUS HELPED ENSURE

PROGRAMMING INCLUDES RECREATIONAL GROUPS, AS WELL AS EDUCATIONAL AND SUPPORT GROUPS. PARENTING SUPPORT AND PARENT/CHILD BONDING ACTIVITIES ARE ALSO PROVIDED TO PARENTS WHO ARE UTILIZING DAIS SERVICES IN ORDER TO AID IN HEALING THE PARENT-CHILD BOND. DURING THE EARLY PART OF THE PANDEMIC, DAIS CEASED GROUP ACTIVITIES FOR CHILDREN TO MAINTAIN SOCIAL DISTANCING AND PROMOTE HEALTH AND SAFETY. TO ENSURE ONGOING SUPPORT FOR CHILDREN'S DEVELOPMENT AND WELLBEING, AND TO OFFER PARENTING SUPPORT, DAIS STAFF PROVIDED FAMILY-BASED ACTIVITIES TO ALL RESIDENTS IN SHELTER AND WORKED INDIVIDUALLY WITH PARENTS TO ADDRESS PARENTING ISSUES OR CHILDCARE SUPPORT. IN 2021, DAIS PROVIDED 132 CHILDREN AND 84 ADULTS WITH THESE SERVICES.
