DAIS Crisis Intervention Advocates are of the first point of contact for many of our clients. Our Crisis Intervention Advocates assist victims and survivors, their friends, families, and other concerned community members impacted by domestic violence issues. Crisis Intervention Advocates provide crisis intervention, crisis counseling and support, personalized safety planning, internal referrals to other DAIS programs, and community resource referrals to individuals utilizing crisis intake services at DAIS, which include the 24/7 Help Line program (phone and text), walk-in clients, and our law enforcement referral program.

### About DAIS:

Domestic Abuse Intervention Services (DAIS) empowers those affected by domestic violence and advocates for social change through support, education, and outreach. DAIS envisions a nonviolent community that actively promotes safety, peace, justice, and hope.

#### **Primary Duties:**

- Provide trauma informed direct services to victims of domestic violence and callers to our helpline
- Provide assistance with safety planning, problem solving, information and referrals
- Respond effectively to challenging situations with clients
- Take appropriate steps to deal with emergency situations with the goal of maintaining the safety of all clients
- Respond to referrals from Madison Police Department
- Assist in on-site emergencies as needed

#### **Qualifications:**

There's no such thing as a perfect candidate. Our clients come from all different backgrounds, and so do our employees. If you're passionate about utilizing your skills in a role like this, and you meet the minimum requirements of the position, we'd love to hear from you.
